



## Nebraska FFA & John Deere Dealer Gator Partner Program

### **Purpose:**

To create a simple program allowing Nebraska John Deere dealers to join in supporting 189 FFA chapters and 9,000 FFA members across Nebraska.

### **How does it work?**

All Nebraska John Deere dealers will be given the opportunity to donate towards the cost of a Gator to be displayed and auctioned at Husker Harvest Days.

The Nebraska FFA Foundation will purchase the Gator. The Gator will be on display at Husker Harvest Days at the auction site with a banner with FFA logos and participating dealer logos on Tuesday. On Wednesday, it will be auctioned off at the annual Nebraska FFA Foundation Auction located at the Titan Tire booth.

### **Your Investment in FFA:**

The Nebraska FFA Foundation is requesting a \$2,000 investment from at least six John Deere dealers. This \$12,000 will allow us to purchase the Gator and all remaining funds will be used on promotional materials for the program.
