



I Believe in the Future of Ag is focused on building financial capacity for the future of FFA in Nebraska. It gives us the opportunity to educate community members on the importance of agricultural education and FFA programs.

The campaign spanned all of Nebraska and included two media partnerships with Husker Sports Properties and KRVN/Rural Radio Network. Industry sponsors donated \$250,000 towards the campaign.

Local FFA chapter donors donated over \$412,000 for their chapters and \$35,000 was awarded to participating chapters in matching funds. The top *I Believe* chapters for 2018-19 were McCool Junction, Ravenna, Elgin and O'Neill. The top chapters are based on receiving at least \$500 in donations and participating in the sponsor engagement contest. Out of the 189 chapters, 133 chapters participated in the campaign.

\$412,000 was donated this past year directly to the chapters, but the funding and volunteer needs at the local level are always needed. To learn more about the program go to neffaoundation.org.
